Basic Information	<ul style="list-style-type: none"> <li>- <b>OPEN Ticket / STAND BY Ticket Issue - Not permitted</b></li> <li>- <b>SOTO Permitted</b></li> <li>- Tickets with reverse order are not available</li> <li>- Passport Validity period should be longer than 6months</li> <li>- Date change only allowed same booking class or higher booking class</li> <li>- Tax are excluded from all fares</li> <li>- When making a reservation, please input APIS info</li> <li>- Please fill in a reserved passenger contact information or email address</li> </ul>

Name rules	<p>Surname</p> <ul style="list-style-type: none"> <li>- If the passenger has one letter Surname, you should put the Surname twice ex) Y/TEST -&gt; YY/TEST</li> <li>- If the passenger has no Surname, you should put the Full Name twice ex) TEST -&gt; TEST/TEST</li> <li>* Check-in is not allowed, if who is not follow above rules</li> </ul>
